

THE DEMOCRATIC CANDIDATE FOR CANAL COMMISSIONER.

In the lives of the Members of the Legislature of Pennsylvania, published in 1848, we find this notice of Mr. Morison, the Democratic nominee for the office of Canal Commissioner:

"William T. Morison, whose parents removed from Petersburg, Virginia, and located in Abington township, Montgomery county, in the year 1801, was born and now resides on the farm where his father first located. He received a liberal education, and at the age of 21 he engaged in agriculture, which pursuit he has continued to follow up to the present time. He has frequently been called, by his fellow citizens, to fill various places of trust and honor. He has officiated as Justice of the Peace, Director of the Public Schools, County Commissioner, and in 1848 he was elected to the State Legislature, in which he performed the part of a faithful and able representative, and won the good opinion of his fellow members by his correct deportment and gentlemanly manners."

Mr. M. was re-elected to the House in 1849, and held a seat during the last session. Always at his post, he never shrank from responsibility, but met every question as it came. His votes were Democratic."

Mr. Morison, we should suppose to be about 45 years of age—is nearly six feet high, slightly but compactly built, and erect as an arrow. He is active and punctual in the discharge of business; and in the very prime of life, bodily and mental.

LATER FROM HAVANA.

We learn from Capt. Ward, of barque Rapid, which left Havana on the 12th instant, and arrived at New York on Sunday, that the trial of the prisoners taken at Woman's Island was still going on, on board of the Spanish seventy-four lying in the port. A large number of gun-boats were kept rowing around her, to prevent any unauthorized persons from communicating with her.

The U. S. Consul, Mr. Campbell, and commander Randolph, asked permission to see the persons confined on board, but the authorities refused to allow them to hold any communication, stating that they would be tried by the laws of maritime nations, and if found guilty, would be dealt with accordingly.

There have been several deaths among the persons confined on board of the seventy-four gun-ship. The captains were kept in confinement on board of the same vessel with those taken from Woman's Island.

Several persons have been arrested, put in prison, and their property confiscated, on suspicion of being concerned in the invasion by General Lopez.

The U. S. troops of war Albany and Germantown were lying off and on in the harbor, awaiting orders. It was the opinion of the American Consul that should the United States government demand the release of the persons taken from Woman's Island, they would be given up without further trouble.
