#### From the Panama Stor, June 17, NEWS PROM BOGOTA.

By the late English mail, we received full files of Bogota papers. From them we learn that Mr. Arosemena's bill, proposing the erection of the State of the Isthmus, has not passed the Senate. The representatives readily admitted and approved the new law though we believe their decision must have been greatly influenced by Mr. A.'s presence in the Chamber. The Senate had no great advocate in it; the bill was therefore considered very coolly, and coolly laid aside. It was said that such an important measure ought not to be adopted without consulting the people of the Isthmus. This is the first time the Senate thought of consulting the people. We think, however, that so far as the people of the Isthmus are concerned. they care little or nothing whether the bill passes or not. We have no desire to com-
