WASHINGTON, Oct. 25 .- The following was received at the head-quarters of the army to-day : --

Sr. Lot is, Mo., Oct. 24, 1862. - To Major-General Halleck, General in-Chief :- Our arms are entirely successful against Northwest Arkansas. General Schefield, finding that the enemy had encamped at Pea Ridge sent General Blant, with the first division westward, and moved towards Huntsville with the rest of his forces. Gen. Blunt, by toaking a hard night's march, reached and attacked the Robel force at Marysville, near the northwest corner of Arkanses, at 7 o'clock A. M., on the 224 inst.

The chenty was under cover, estimated at some 5000 to 1000 strong. The engagement insted about an hear, and resulted in th total rout of the energy, with the loss of all his artillery, a battery of six pounders, a large number of horses, and a portion of their transportation, camp and garrison equipage.
