**The National Convention Bill passed the House of Representatives on Wednesday last week, nearly as it came from the Senate, by 69 majority, the vote being 113 yeas, to 49 nays. All the Republicans voted for it but one, and all the Democrats voted against it but three.**

The bill renders perfectly valid, all payments made and contracts or agreements entered into by County Commissioners or other officers on account of such volunteer bounty fund. This will legalize the appropriation made by our County Commissioners.**
