Cultivate domestic habits, for this your famiiy, if you have one, has a strong and undeniable claim : besides, your customers will always be best pleased when they find you at home, or at a place of your busines.

Never let hurry or confusion distract your thind.

Under the influence of such habits as these with a suitable dependence on Providence for a blessing on the labors of your hands, you will have a good foundation to rest your hope upon, employed in.

No Penna. Wheats at market, Sales of Maryland Com to-day at 42 a 43 cts. for white, and 44 a 45 cents, for yellow .- Sales of Osts at 23 a 24 cis.

WHISKEY .- Sales were made to a considera. the extent on Saturday at 23 cts. for hhds, and 24 ets, for bbls. These transactions left the market very nearly bare, and the article is now scarce and in demand.


