These trips are to be performed as additional voyages, and irrespective of the fortnightly voyages to Halifax and Boston ; as this latter service will continue just as at present, with the alteration of miling from Liverpool as well as from Boston, elways on Saturdays instead of a fixed day of the month, as at present. The steamers to New York will also take their departures always on Saturday. By this arrangement there will be a steamer from Liverpool to America every Saturday, and from the American side evvery Saturday, the only difference being that Boston and New York will alternately be the ports of departure. 
