## Astronomy Open House looks at the eye

On Thursday, November 2nd, Dr. Jonathan Hall conducted an astronomy open house in room 101 of the Science building, with the topic of "Light and Color." Dr. Hall began the night by explaining several early theories of light and then broke up the night's topic into two sections: "What is Light?" and "The Eye."
