ascertain who is in the building in By Becky-Lai lance Staff writer Dean Betty Seanor, assistant dean of Student Affairs, has announced that the Office of Student Affairs has case of fire or other emergencies. In addition, those regulations contained in Policies and Rules for Students 1971 - 72 under "Student Conduct", page 26, will be observed:

Administration Accepts

1. Students are permitted to have visitors in their rooms only if there is no objection from their roommate.

2. Any unescorted visitors of the opposite sex at any time in any residence hall shall be presumed to be in violation of these rules and procedures. An unescorted visitor who is a student of the University shall be subject to University discipline.

3. Persons who are not students of the University shall be entitled to visitation privileges in University residence halls only if they register with the residenthall staff member -in advance. University students will be held responsible for the presence of non-University visitors.

4. Any visitor in bed is considered to be in violation of this policy and the guest permission policy of the Department of Housing and Food Services. Such guest permission is limited to persons of the same sex and prior approval is required from the residence hall staff.

5. All pertinent state and local laws must be observed. Failure to comply with the above procedures will result in a review of the program by the Office of Student Affairs.

These students not wishing to accept the actuality of open house will have the opportunity to make known their feelings. These students should feel free to vote without being intimidated.

Vistation Privileges Seanor replied, "It is up to the students themselves to cope with the whole area of responsibilities that come with the new hours.'

Representatives from the Joint Residence Council met Tuesday night, October 12, 1971 at the home of Dean Seanor to discuss the new proposal. Art Sprague, Sudee Potter, Bill Connor and George Frola worked with Mr. Fiorentino and Miss Carroll on the formation of a survey to be given Thursday.

The initial survey will be very general. The three major questions that will be considered are as follows:

1. Would you prefer to live on a floor where no visitation occurs?

2. Would you prefer to live on a floor where visitation hours from last year are still in affect.?

3. Would you prefer to live on a floor where the new extended visitation occurs?

The questionnaires will be collected Thursday evening. The new floor representatives in each hall will handle the collecting of the ballots. The ballots will be given to George Frola (acting chairman-visitation committee) on Friday. Miss Carroll will then file these ballots at the Office of Student Affairs. It is to be made quite clear that the ballots will be held in strictest confidence.

After the collection of the ballots, the representatives of the JRC will meet to decide what further steps need to be taken.

The entire process should take no more than two weeks provided there is complete cooperation from the students.

George Frola stated that "visitation should not be taken Asked how she feels about the approval of this proposal, Dean for granted. It is a privilege that is not to be abused."
