To the Editor:

In my experience as a college student, I have run across all types and strains of individuals. Many of these have typified the worldly conception of the college student: bright, aggressive, wellspoken, etc. . . . But last week I had the misfortune to run across what Social Psychologists have labeled the "Authoritarian Personality." This young gentleman or "bigot" whichever the case may be, was explaining to a group of students his "very own" personal philosophy regarding racial prejudice. Many of you may not know this, but according to Dave Works (he asked to have his name printed) blacks and any other non-white race are inferior to the typical White Anglo-Saxon Protestant for several different reasons. To Dean Lane, Dean of Student Affairs:

This September, the Student Union Board appointed Ms. Mary Ann Ladd to the position of

temporary Special Services Chairperson. It is only wished that the sexist policies of Mr. Jay DiFrank and the 1976 Student Union Board be

placed on record. Thank you.


