Saltzman Analyzes Year-Long SGA Tenure

"I think I represented the students of Behrend well, their needs and expressions, to both the Administration and the Faculty Council," said outgoing Student Government Association President Doug Saltzman, in a recent Collegian interview. Saltzman did not seek re-election to the SGA position.

"I'm glad that I was able to work well with the new Senatorial positions developed by (former SGA President) Ed McCloskey," said Saltzman.

Assessing his performance, Saltzman feels that the major accomplishment of his administration was "initiating the drive to

organize the student government. We've put a bit more professionalism into it, something which was previously lacking in part. And I think that the new constitution we ratified was the most important factor of this re-organization."

"Another significant accomplishment," he continued, "one that most students won't be aware of, is that it's now very likely that Behrend will soon have a representative on the Faculty Senate of University Park. This is a tremendous step for our campus."

Saltzman also points to the large part the SGA played in securing major grants for Behrend. "We'll be able to have

new lighting for the Reed Lecture Hall, and we're getting a large screen TV for the RUB lounge, which should help improve conditions for commuters. We were also able, through grants, to get significant amounts of money for the Yearbook," he said. "I was really happy to see that get going again."

"We also played an instrumental role in setting up the first SGA area conference," Saltzman said. "Having the opportunity to meet with other student governments can only be helpful."

Discussing the recent Student Government Association elections, said "I think Dan Johns (the newly elected SGA President) will have a good base to work

from next year. I have confidence in him, and in his vice-president, Doug Gerow, who has extensive knowledge of student government."

"Doug and I collaborated well last year," continued Saltzman. "He was one of the hardest workers in the SGA. I'm sure he'll do an excellent job next year, too."

Addressing his future plans, Saltzman said he's "looking forward to working with the new student government. I'll be doing committee work, and I'll be working closely with Dan."

"Overall," he said, "I'm very happy with what's been accomplished."
