






WZAP Plans To Have FM Operation

Did you know that WZAP seriously planning to become an educational FM radio station? The drawing (LOCATION) is the way the new station could look in the near future if plans, being worked on now, are adopted.

The facility is expected to be located on the third floor of the main building and will consist of four studios. Studio A will be the master control studio and house the FM transmitter. Studio B will handle production and have control of Studio C. Studio C will be used for the recording of or live presentation of group discussions or small musical groups. Studio D will be the news delivery booth. Extensive patching networks will enable the studios to be interconnected singly or in combination with other. This will allow three separate activities to take place within the facility without disturbing the FM operation going on in Studio

The following information is considered public information which may be made available without prior consent of the student: name. address(local and permanent), telephone number. date and place of birth, major, student activities including sports, weight/ height, dates of attendance, date of graduation, degrees and awards received and most recent educational institution attended.

The student may use the new confidentiality form to request that any or all of this information not be made publicly available.

The form may also be used to indicate which inquirers may or may not receive copies of or information from a student's academic record.

All students should have a confidentiality form on file with the Records Office.
