Deanna Klinger, president of RCC, said, "Last year's event raised over \$1,000. This year we hope to cover our own expenses and give what we can to the Four Diamonds Fund."

The Four Diamonds Fund is a foundation that ensures any expenses associated with the care and treatment of children with cancer will not become a financial burden for the patients and their families. Any expense not

covered by insurance or by other means is paid for by the fund.

This second annual event drew in a crowd of about 80 participants and 28 contestants.

Contestants were called to the stage one by one and described to the audience. The crowd bid on any contestant they chose.

Bids ranged from \$6 to a high of \$70, providing a nice profit for the Four Diamonds Fund.

The top dollar amounts were \$70 for Deanna Klinger and \$65 for Matt Williams. These two

contestants stole the stage by sharing secrets, hobbies and dating fantasies with the audience.

In all, RCC raised approximately \$725.

Thirteen local businesses donated gift certificates for the event. Those businesses were Midtown Pizza, Brownstone Cafe, Dominos Pizza, Blockbuster, Cracker Barrel, Lamp Post Inn, Champions, ABC Lanes East, Gilligans, Pagliaros, Colonial Commons, Cinema Grill, and T.G.I. Fridays,
