The Inter-campus Tournament for the winter term, 1964, will be held at the New Kensington Center. The participants include all Commonwealth Campuses.

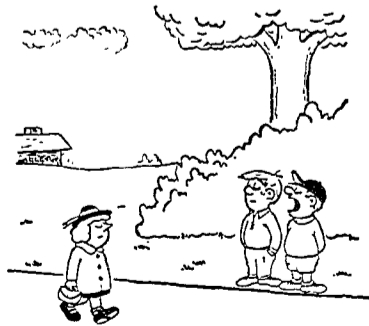

Enrollment at the 14 campuses by 1970 is projected at 10,000 when the number of students at University Park should reach its 25,000 peak.

Long range predictions, however, have been made on the assumption that Penn State will continue to enroll about 10 per cent of all college and university students in the Commonwealth, as it has for the past several years.

From 1970 to 1980 the figures indicate almost all the University's growth will be at the campuses spread throughout the state. Enrollment at the Commonwealth campuses during the fall term

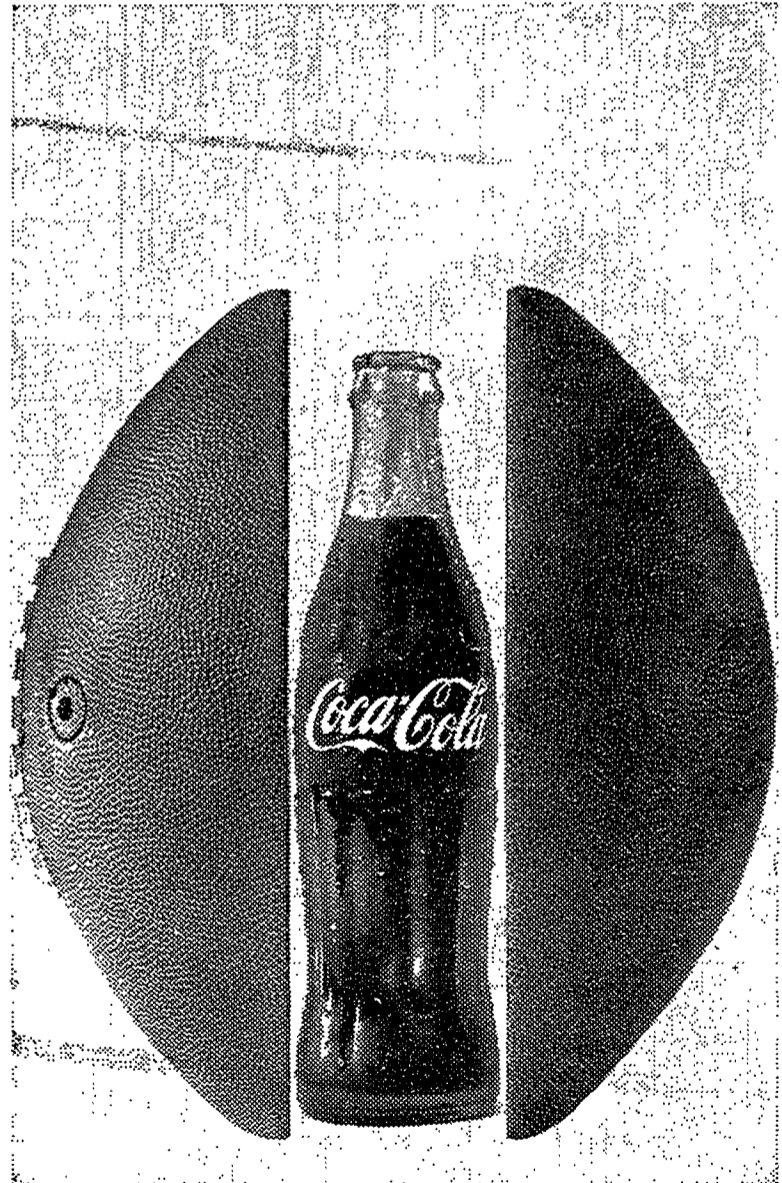
was only 4,226, as compared with 22,842 at University Park.

Because officials believe more than 25,000 students at University Park will prove to be "cumbersome," Holderman said, plans may soon be underway to offer more than two years of study at the Commonwealth campuses.

Holderman said there are no current plans to develop new campuses, although several campuses are planning moves to new sites because of overcrowded conditions.
