Thursday after the demonstration in which there were several pitched baltles with the JOCKS and these people I mentioned were urging them on. was pulled off the flagpole where I was speaking by Bill Stansfield and several other people. Fortunately they fought like girls and we all have scratches and teeth marks, and they have black eyes and a few of them won't be having sex for a while ... but they stopped us, they pulled me back. They told me to calm down, and I told them to get fucked. I told Dr. Murphy to get fuked yesterday and I told Dr. Lewis to get fucked yesterday. And after the demonstration, Thursday, Paul was arrested....Col. Pelton walked out here and asked if I knew a kid. And then he said now I can find him, and he walked over to the kid and said, "They have a warrant for your arrest up there, do you want to go up and see the lieuten ant of the State Police?" said, "No, if he wants me he can come down and get me.? So we started to walk away with Paul and a local policeman and this undercover agent walked up, put their hands on Paul's shoulder and said, "stay here." And Dean Rhod

es came down, Asst., he's on the Dean of Students' Staff, and they said, "Dean Rhodes, is this the boy?" And he said, "Yes." And they said, "You're under arrest", slapped the handcuffs on him behind his back, and dragged him away.

.....We blocked the car until they just about ran &ver us, and we prunded the shit out of it for a while. Then we went down to the police station and we collected one-hundred dollars bail, because there were five warrants out. Paul's bail was first two-hundred dollars, but we convinced them to lower it to fifty dollars, because don't have the two-hundred dollars. The interesting thing for people to look in Saturday's New York Times, on page 23 there's a picture of the balck brothers at Freensboro who were busted for shooting at the National Guardsmen. 'And they're leading them into the police station, with their HANDS ABOVE THEIR HEADS AND NOT ONE OF THEM'S HANDCUFFED. Yet Paul was being taken down for malicious mischief, specifically for breaking the lock, a University lock, was handcuffed and dragged away. So we've issued five demands to the administration, and we got a response-if you get ahold of today's COLLEGIAN [May 25 you can get the response. And you can probably get the demands better than I can give them. they most immediately remove all undercover agents from the University Campus They must immediately drop charges I am not a member of for all students for whom warrants are out; they must immediately begin a process for informing a stu dent before any police come on cam pus and arrest him that he will be arrested and what the charges will be so he can get legal fee and bail; and that they must take legal action against Mr. Elias, Mr. Pelton, Mr. Barnes, and Mr. Scott who were urging people to fight. Their positions are desdribed in the COLLEGIAN. And we intend to press these demands. Today we're out here, proasting a pig, it's sort of like what the people want it to be. This has been declared Peoples Park East. It can be the fact that the only good pig is a dead pig. Plus solidarity with the brothers; out at Berkley, and it's also a program we're going to work now with the BSU. We're going to take University property, I said take because they won't give it to us we asked yesterday. Land on the outskirts that's vacant. going to actually build a park and there is a large black community in Mountain Union, and a

large white community in Snowshoe, who are poverty stricken. While at State College, which is only a couple miles away, their fat It is the stomachs get fatter. most affluent community in Appalachia. And since the University won't fulfill the role, going to do it for them, so the blacks and the white radicals of SDS are going to get together and We're going to build this park. start a program and work on it during the summer and later on we're going to try to have these things every weekend, -- drive the kids up and their parents will be bringing them up. We want to really organize this, and this is what we intend to do--with or without the administration. also intend to have these demands granted. They can argue about our other demands, and they can say that they don't have the money -don't have the time. But they better find the time, and it takes no money to grant what we ve demanded now. And they re going to do it or I really can't be re-sponsible for what the students might do up here.
