SELECTIVE SERVICE

In accordance with regulations prescribed by the Selective Service Military Act of 1967. University officials will no longer report class standing and grades of students to Selective Service Local Boards.

The new legislation provedes for student deferment to be based primarily on enrollment of the student and normal progress toward his degree.

To assist the student in requesting an undergraduate student deferment the Selective Service System has devised SSS Form 104, which was made available to all students at Fall Term registration.

The undergraduate completes and files this form with the his Local Board only once while he is a Student.

The student seeking a deferment requests that the Records Office keep his Local Board informed on his status.

This month the University will report to the Local Board, advising the Board of the student's full-time enrollment.

on Sept 24, 1968, the University again will report advising the Local Board as to whether or not the student is full-time. The report will also include statements on his progress and expected graduation date.

Graduate students are required to use a letter rather than the SSS Form 104 to request deferments by their Local Board. They should also report in person to the Record Office to request the University to advise their Local Board of their status.

Since the designation of critical occupational areas has not yet been completed the existing deferments for furl-time graduate students or those with assistantships will continue through the present academic year.

A student receiving an induction notice issued while a full-time student may be eligible for a post-ponement of induction or the classification of 1-S.

Requests for such deferments, or appeals are a matter between the sudent and his Local Board.
