First, dress appropriately. Businesses like professional people, and if you can pull that off, you already passed the first part. Business attire includes neutral colors, like blues and grays. Black also never fails.

Make sure your résumé is well written and free of grammatical or format errors. Résumés speak for you before you have a chance to. It's good that you already have the interview, but they might request your résumé or ask questions about it. Be prepared to answer any questions that arise.

Be on time. Remember: to be early is to be on time, to be on time is to be late, and to be late is never acceptable. Make sure you know your way to the site, and allow room in your travel time for possible delays due to traffic, accidents, etc. This is not a time to experiment. If you know/are specific to a route, stick to it.

Speak eloquently and clearly. You already got this far, so don't be nervous. They chose you for a reason, so show them some more. Be polite and show them how much you want it.
