Dear Mr. Cianci:

I am replying to your letter to Mr. Robert A. Patterson of September 11, 1975 regarding general deposit charges. The Bursar informs me that one of the \$3.00 charges was in error and that you will receive a refund of \$44.00 on your general deposit.

All students in chemistry laboratory courses at our Commonwealth Campuses are charged \$3.00 per term by way of a charge against the general deposit. Our procedures call for the student to be notified of the charge by his instructor in each such class. If for some reason you were not notified, we are sorry, but our policies do not permit refund of the charges.


