Dear Campus Community:

As you may know, one of the goals referenced in our campus' new strategic plan focuses on improving safety and security on campus. Training and preparedness to handle a variety of on campus emergencies are ways we can help achieve this goal. As such, we are in the process of working with the Pennsylvania State Police and other agencies to plan an emergency preparedness drill to improve our readiness and that of first responders during and after a crisis.

The emergency preparedness drill will take place sometime on Thursday, March 5, 2009, and we do not anticipate the activity to last more than 1.5 hours. Everyone on campus at the time of the drill will become part of the activity in one way or another. However, those who are interested in playing a larger role in this exercise can serve as volunteer "victims." More details concerning the drill will be forthcoming via faculty senate and staff forum meetings. In the meantime, if you wish to volunteer to play a role in the activity, please contact Lisa Yerges at lyerges@psu.edu by Friday, February 13, 2009. The time commitment for volunteers will be approximately (1) one-hour meeting with the State Police the week before the drill and two hours of time on the day of the actual drill.

Attention Student Community Reminders About Campus Driving Regulations

The campus speed limit is 13 mph.

Always be cautious when driving on the campus or pulling out of your parking space.
