



A Yes, if an actual mistake was made and you owe them additional money, you must pay them The fact that the company made a mistake is unfortunate but does not relieve you of the responsibility of repaying the correct amount

Q I am a widow with one married daughter and two grandchildren. I also have one sister, my father's aunt and stepmother's daughter If I die without leaving a will, who will inherit whatever my estate?

A Under the Intestate Act f 1947, if you die without a Will leaving no husband to survive you, then your entire estate would go to your issue, viz, your married daughter. In order to insure the proper administration and distribution of your estate, you should consult an attorney to prepare a Will fully expressing your intention.
