

absorbent paper and keep warm. Four one-fourth cup of bacon drippings into a small skillet. Cut fresh pineapple into fingers or sticks three inches long and one-half inch square. Brown pineapple in drippings and sprinkle sugar over pineapple. Spoon drippings over pineapple until glazed and serve on a warm platter with the bacon. Four servings.



Tobacco Price, Use Show Drop

Disappearance of Pennsylvania and Ohio filler in the year ending Sept. 30, 1957, is preliminarily estimated at 59 million pounds, compared with 62 million in 1955-56. Nearly all of the continental cigar filler types are used in domestic cigar manufacture. Indications are that domestic disappearance in the first half of the marketing year was six per cent below the comparable months of last year.

Exports in October 1956-April 1957 were substantially higher than a year ago. They amounted to approximately 465,000 pounds. Most of the exports went to Algeria.

Prices for the 1956 Pennsylvania filler crop averaged 24 cents, one-half cent less than in 1955 and three and a half cents less than the average prices of each of the 1953 and 1954 crops. The average price for the Ohio crop was 22 cents, up a little from 1955.

The report also shows that Pennsylvania farmers grossed \$11 million from tobacco last year. This is 15 per cent of the total state farm income and is down \$2 million from 1955.

Compared with the 1950-54 average, prices received are down a million dollars and percentage wise, down a tenth of a per cent.

Acreage this year, according to March 1 intentions, is about the same as last year. The acreage in type 41 tobacco has risen steadily since 1952 when only 28,700 acres were planted.


However prices have showed a steady drop since 1953 when the average was 27.5 cents a pound.

Pennsylvania filler type 41 is not eligible for government price support, as growers have rejected marketing quotas on 1956, 1957, and 1958 crops.

The present parity price on supported cigar tobaccos is 29.3 cents. The tobacco is supported at 90 per cent of parity.

86. Pct. of Farmers Voted Yes for Quotas

Final results of the June 20 referendum in the commercial wheat-producing area show that 86.2 per cent of the 235,039 farmers voting favored marketing quotas for the 1958 wheat crop. The vote was 202,68 for (86.2 per cent) and 32,371 against (13.8 per cent).
