HARRISBURG - Trends toward sagging meat prices failed to hit Pennsylvania livestock pro duers as hard as those of the naAgriculture said today.

In spite of the fact that the index of prices received by Penn sylvania farmers showed a decline for the fifth consecutive month, Crop Reporting Service surveys revealed that red meat animal price index was 20 per cent amove a year earlier. Nationally, the ad vance was 12 per cent.


Q. On my vacation I was in a town where they had an auction sale and I bid on a trunk and its contents. It had silver, clothes, books and small trinkets

Among these things was a bank look Can I collect any of that nioney shown in the bank book? The man to whom it belonged is supposed to be dead


A Assuming that you are referring to a savings account passbook, whether you can claim the money in the savings acount by having possession of the passbook would depend on the circumstances under which the sale of the trunk and its contents was made It is possible to make a transfer of a savings account by delivery of possession of the passbook, coupled with the intent to make an assignment of the ac-

Should you attempt to claim the money in the acount, you would have to show that it was intended that ownership of the savings account was intended to be transferred along with the sale of the trunk and its contents. This might be quite a diffiult thing to prove, and it is suggested that you consult your lawyer.
