No New Soil Bank Contracts

There will be no sign-up in 1960 or later are no longer eligible to be extended for an additional period of years.

"Under the Soil Bank Act enacted in May of 1956," Mr. Groff, Chairman of the Pennsylvania Agricultural Stabilization and Conservation Committee, said today in response to inquiries from farmers regarding the status of the program. Mr. Groff also said that program contracts which ex-

1960 program was held last year, so that farmers would know in advance of the cropping season whether their land would be accepted into the Conservation Reserve. Since the authorization to enter into new contracts has not been extended beyond 1960, there will be no sign-up period this fall.

"Farmers should understand, however, that the existing contract for 1960 and previous years will remain in effect and payments will continue to be made under them for the period of the contracts and in accordance with contract terms.

Is Rescheduled
Second Time**

The joint public hearing to consider amending fluid milk prices in Northeastern markets has been rescheduled to open Dec. 6 in New York City, instead of Oct. 3, as previously announced.

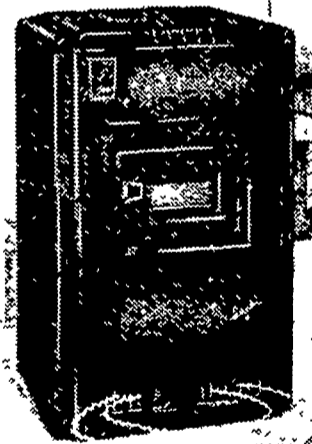
Postponement of the hearing to the December date is at the request of industry representatives.

Subject of the hearing will be Class I (fluid) milk prices under the Federal orders regulating milk handling in the following marketing areas; Boston, Springfield, Worcester, Connecticut, Southeastern New England (Rhode Island and part of Massachusetts), New York-New Jersey, Philadelphia, and Wilmington.

The date for submitting additional proposals to be brought before the joint hearing also was extended. Interested parties now will have until Oct 15, 1960, to submit proposals.
