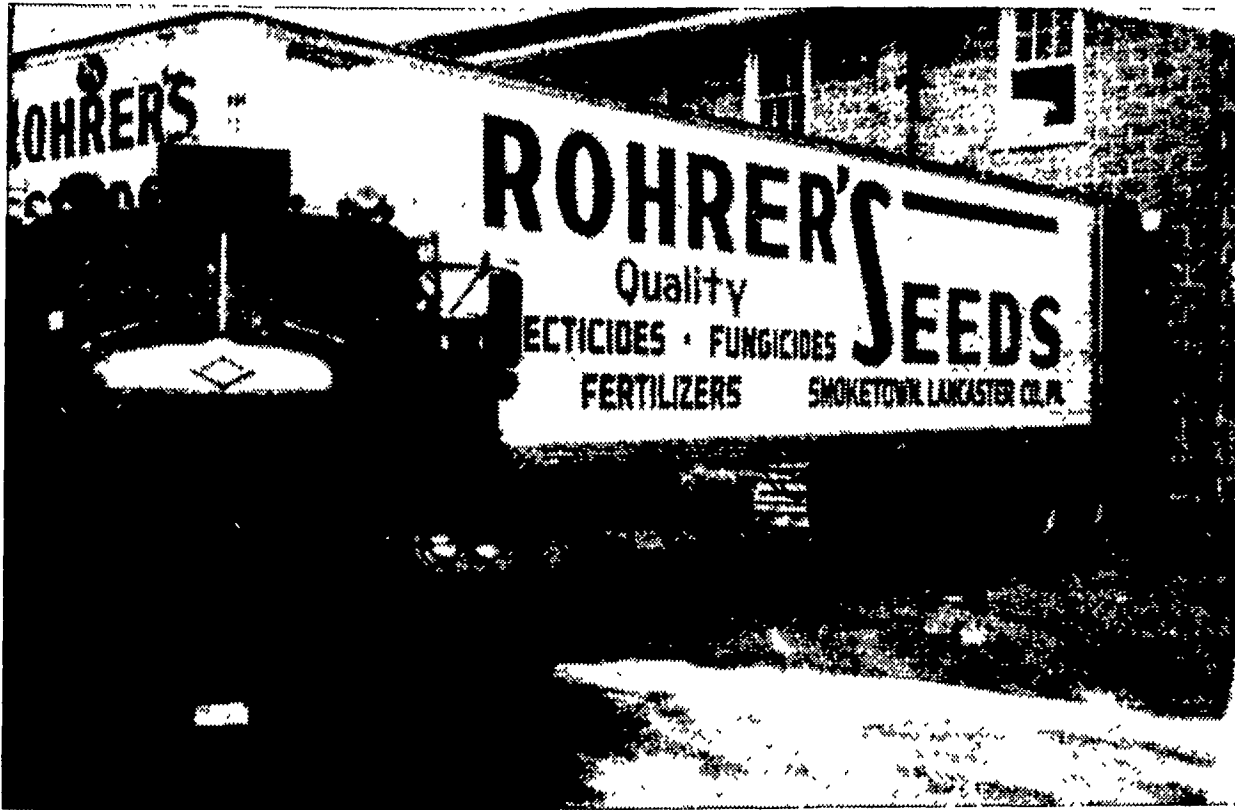

Pa. Livestock Association To Meet At Lanc.

The Pennsylvania Certified Livestock Markets Association will hold their annual meeting in Lancaster County at the Holiday Inn, Route 501, Lancaster, July 18-19.

On the agenda is a visit to the Vintage Sales Stables Inc. new sales facilities at Vintage, Friday morning, July 18.

The Friday afternoon session at the Holiday Inn will be addressed by the following speakers: Mr. Max Smith, Lancaster County Farm Agent; Mr. Louis Moore, Agricultural Economist, Penna. State University; Dr. Forney, Pennsylvania Department of Agriculture; Dr. Mainwaring, United States Department of Agriculture; Mr. John Hinkle, Pork Producers Council; Mr. Bruce Johnson Certified Livestock Market Assn. Representative; Mr. Tad Sanders, General Manager of the Certified Livestock Markets Assn.

The annual banquet will be held at 7:00 p.m. Friday with H. V. Rockhill, Chairman of the Board of the Certified Livestock Markets Association, as speaker.

Saturday morning, July 19, the organization will hold a business session and election of officers. Harold A. Hess, Secretary-Treasurer of the Vintage Sales Stables will preside as this year's outgoing president.

campus at The Pennsylvania State University on Thursday, July 24.

A letter of invitation to go with the group by bus to Penn State for the day was sent to livestock producers this week by County Agent M. M. Smith.

The cost will be \$5.00 per person for the bus transportation round trip and lunch will be furnished free at noon from the Meats Laboratory.

The bus will meet the group at the Lancaster Shopping Center at 6:30 a.m. and should arrive home between 7:00 and 8:00 p.m. Reservations must be made with Smith at his Farm and Home Center Office, 1383 Arcadia Road, no later than Tuesday, July 22.

The Field Day is for all four species of livestock — beef cattle, swine, sheep, and horses. The morning program starts at 10:00 A.M. with a separate program for each type of livestock at different locations. The noon lunch will be for all persons at one place followed by a brief speaking program. A sheep dog driving demonstration will be given during the noon hour to add variety to the program. Brief tours of the Deer Research Center — Soil and Forage Testing Lab — Breeding Research Center — and the Haller Research Farm will inform of some things being done at our State University.

For the benefit of any football fans the color movie, "The Year Of The Lion" will be shown during the afternoon; this picture includes the highlights of the 1968 Penn State's winning football season.

"There are many changes taking place at Penn State each year," Smith said. "The new beef cattle barns and the swine center demonstrate modern production methods. We hope that you will accept this opportunity of learning more about your land-grant university and many of its agricultural research programs."
