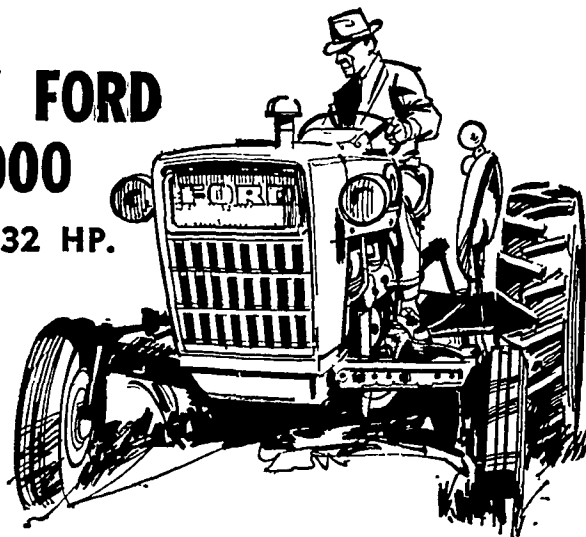

Bulgaria, Romania Plan To Export Meat to U.S.

Based on an extensive investigation and evaluation, the U.S. Department of Agriculture today proposed that the meat inspection programs in Bulgaria and Romania be declared equal to the U.S. inspection program and that the countries be made eligible to export meat to the United States.

The conclusion that these two countries have inspection, building construction and other requirements equal to the U.S. program was reached after point by point comparisons of their laws and regulations to U.S. meat inspection laws and regulations. In addition, foreign review officers from USDA's Consumer and Marketing Service observed the inspection program in action in the two countries.

C&MS said both countries have an abundance of state-employed veterinarians working in comprehensive meat inspection programs. Canned ham is the principal product they propose to export here, C&MS said.

Federal meat inspection laws prohibit the importation of meat from any country which has not been judged to have an inspection system equal to that in the United States. Once a country's inspection system has been approved, that country

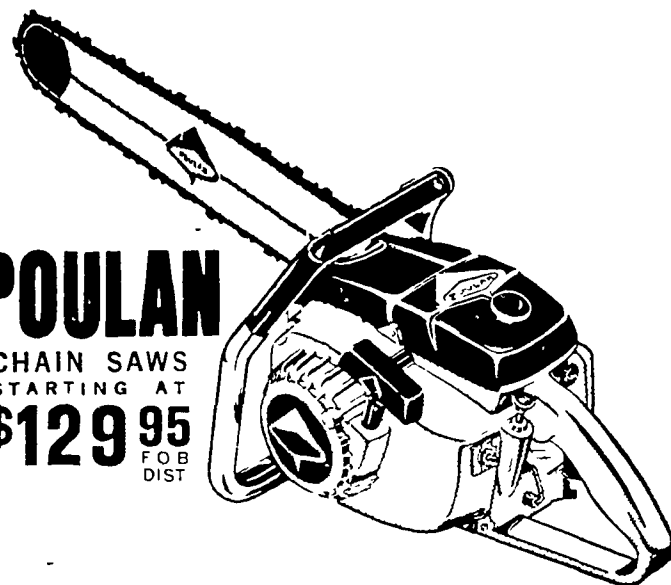
will certify individual plants which it finds qualified to export meat. Each of these certified plants is visited at least once a year by a C&MS foreign review officer.

In addition, once meat from approved countries arrives at U.S. ports of entry it is subjected to various tests to assure wholesomeness.

holds; (3) unmarried individuals (other than surviving spouses and heads of households), and (4) married individuals filing separate returns.

Finally adjustments are being made in the income tax withholding on wages in order to bring taxes withheld closer to an employee's final tax liability after taking the above changes into account. A significant change will eliminate the requirement of withholding for taxpayers, such as students with summer jobs, who incur no final tax liability and who previously have had to file returns for the sole purpose of claiming a refund of taxes.
