#### Poultry Processors Discuss Legislation

At the recent meeting of the Pennsylvania Poultry Processors Association William D. LaCour, Planning Analysis, Solid Waste Section, Bureau of Housing and Environmental Control reported on Act 241 (as ammended), Pa., Solid Waste Management Act.

He stated that beginning January 1970, the Act officially required permits for all solid waste disposal.


"The Module, which was mailed to members, should be completed by a qualified individual such as a geologist, soil scientist or hydrology scientist.

The specialist is necessary, because background data on soil and geology of the area is required."

An explanation of some of kthe requirements were offered and those in attendance received handout material on the subject.

The material included a copy of Act 241, Instructions - Ground Water Report, Rules and Regulations for Administration of the Pennsylvania Solid Waste Management Act, and list of Solid Waste Cordinators and the counties serviced.

The US Sisk Bill and the Pa. Senate Bill 892, having to do with bargaining, were discussed briefly It was suggested that the Association send another letter to the Pennsylvania Legislators clarifying two areas in the previous letter

The high rate of broiler condemnation in Pennsylvania was discussed Apparently some progress has been made since the previous meeting, but the problem deserves further exploration

A request was made to send copies of the pamphlet prepared by N B C titled - "How Growers Would Really Fare Under Compulsory Bargaining"

The meeting adjourned at approximately 3 p m Notes from which the minutes were prepared were generously taken by Kermit Birth


