Research Group Predicts '72 R&D Investment Gain

Record total expenditures for research and development of \$30.1 billion are expected in 1972 according to the annual forecast for 1972 of the Battelle Institute, Columbus, Ohio.

The prediction represents an 8 per cent rise over the estimated 1971 total of \$27.8 billion and the largest per cent increase since the mid-1960s.

The increase will be the result of a record level of federal support, higher even than the previous peak figure of 1969, and from a continuing upward trend in support from industry and private sources.

Estimating corporate funded R&D by broad industry groups, the forecast identifies the top spenders as:

(1) transportation equipment and missiles, with 1972 R&D expenditures of \$2.8 billion;

(2) electrical equipment and communications, \$2.7 billion; (3) machinery, \$2 billion; and (4) chemical and allied products, \$1.9 billion.
