

But it works the other way, too. If you change to a less hazardous occupation, the company may reduce the premium and return the excess previously collected, to the date of the change or to the anniversary date. Note that each insurance company has its own classification of occupations and the premium rates.

Q. A man I know recently purchased a comprehensive major medical expense policy at a remarkably low price for someone who will soon be 60. I frankly think he lied about his age. If the insurance company finds out about this, what can it do?


A. The company can, of course (if it has evidence) refuse to insure this man But if the misstated age is discovered after this man becomes sick or injured, the insurance company has the right to prorate his benefits so that he will collect only the amount that the premium he paid would have purchased at the correct age.

Q. Every time I talk to my life insurance agent he tells me about the importance of the "cash value" of my life insurance. He seems to think it's the greatest thing invented since money. Can you tell me what's so important about this cash value to me and my family?

A. Cash value in a life insurance policy, you see, 15 money. And its steady buildup offers a

A whole life policy offers other possibilities, too. Every policy with cash value can be converted into an annuity, with income payable for life

Q. I've just turned 65 and have retired. Now, with a reduced income I'd like to stop premiums on my life insurance. Can 1?

A. Certainly. You can arrange to have premiums stop at age 65 on any cash value policy. The cash value can be applied toward the purchase of a fully paid-up but smaller policy.





