Lancaster County Farmers Assn.

More than 20 resolutions will be presented by the policy development committee at the annual meeting of the Lancaster County Farmers Association. The annual meeting will be held at the Harvest Drive Farm Motel Friday, October 20, at 7.00 p.m. Tickets are available until October 16 from any board member or the secretary.

To become policy of LCFA, a resolution must receive a

majority vote of all families at the meeting, each family getting one vote. Among the resolutions to be considered are:

— That PFA support a policy to prohibit the striking of farm workers during harvest and critical periods of production

— That PFA attempt to regain meat inspection at a state level

— That PFA pursue a higher class 2 milk price, based on cost

of production and increasing demand.

— That PFA introduce legislation to require senate approval of all persons appointed by the governor

— That Farm Bureau launch an extensive research and education program for farmers in the marketing and bargaining processes of open market and contract buying and selling

— That PFA revive the silo tax bill or initiate a new one

— That PFA encourage the preservation of farmland, open spaces and the maintenance of natural environment by supporting land assessment on the basis of use and not on market value

— That properly managed township dumps be left open by the state.

— That PFA recommend stricter penalties for littering because of the hazards to farm machinery and livestock.

— That PFA recommend stricter regulations on weed control on non-agricultural land.

— That PFA recommend that landowners and operators may not be held liable for accidents on their property by trespassers, hunters, snowmobilers and mini-bikers
