An amendment of regulations under the Plant Variety Protection Act was proposed by the U.S. Department of Agriculture (USDA). The proposal would establish the reciprocity limits to be recognized in issuing certificates

USDA's Agricultural Marketing Service (AMS) said equal rights would be recognized in issuing certificates to applicants from the Federal Republic of Germany and the

Netherlands for the genus and species on which applications are accepted in those countries from U.S. nationals.

Certificates issued to persons from the United Kingdom, however, would be limited to 15 years, or less, for certain species and would not include the right to exclude others from offering the protected variety for sale. Rights granted under the PVP Act would hereby be equal to those granted in the United Kingdom.

Rights to U.S. plant breeders are for a maximum of 17 years and include the right to exclude other from offering the protected variety for sale.

The proposal appeared in the Federal Register May 25. Persons wishing to send in comments should submit them, in two copies, to the Hearing clerk, Room 112-A, U.S. Department of Agriculture, Washington, D.C. 20250, on or before June 24. All

comments submitted will be available for public inspection.

Minnich, a salesman since he began his tenure with Pennfield, is a 27-year veteran of the company.


Trostle, also a salesman, has

Place House Plants Outdoors in June

House plants, both the foliage and flowering kinds can be placed outside in a sheltered area, say Extension ornamental horticulturists at The Pennsylvania State University But remember foliage plants such as snake plant or philodendron are best put in a lightly shaded area. Most flowering plants such as geraniums do best in full sunlight. To prevent the soil from drying out too rapidly, plunge the pots into the soil up to their rims. Do not let plants dry out during a drought.
