Everett Weiser, RD1, York Springs, has been elected chairman of the Pennsylvania Red Cherry Marketing Board, it was announced today by Secretary of Agriculture Jim McHale.

William Wilson, RD1, Biglerville, is vice chairman, and Earl Shutt, Orrtanna, secretary. Other members of the Board include Donald Trostel, RD1, Biglerville; Emery Etter, Jr., RD3, Chambersburg; Alfred Pero, North East.

The Board estimates the state's red cherry growers will contribute about the \$9,000 from the 1974 crop, with the money to be used for both national and in-state promotion of processed cherries.
