## Hearing slated on use of Lancaster streams

HARRISBURG - A public hearing is scheduled for May 3 which will affect the future use of Lancaster County streams. The reason for the hearing is the recent publication of the Department of Environmental Resources' (DER) proposed revisions to the State's Water Quality Standards.

Report contains recommendations concerning "high quality waters" and "exceptional quality waters". Also, there are proposals in the Standards for protection of Trout Stocking Fisheries and Cold Water Streams.

Streams in Lancaster

Among other things, DER's County affected by the Trout Stocking Fisheries revisions will be Black Creek, Climbers Creek, Little Cocalico and portions of Conestoga Creek. Other streams affected will be Mann's Run Basin and portion of Octorara Creek. Under the proposed new regulations, these streams will be

maintained at their present high quality for the uses proposed in the revised Standards. The classification of these streams will ultimately establish by regulation the amount and quality of effluent allowed to be discharged by industries and municipalities.

## N.J. meat packer charged with failure to pay \$193,000

WASHINGTON, D.C. -Victory Beef Co., Corp., Patterson, N.J., has been charged with failing to pay for more than \$193,000 worth of livestock and meat in violation of the Packers and Stockyards (P&S) Act.

The firm purchases hvestock throughout eastern Pennsylvania and New Jersey and meat in New Jersey. U.S. Department of Agriculture officials said the firm has temporarily suspended its packing operations.

In an administrative complaint filed under the P&S Act, USDA charged the firm with:


•Failing to pay, when due, the full price for more than \$131,000 worth of livestock and \$62,000 worth of meat;

•Using funds that should have been held in trust.

The firm has a right to a hearing. If the charges are proven, it would be placed under a cease and desist

Meat packers are required under the Act to maintain a solvent financial position and to pay promptly for livestock and meat. They must also hold in trust any funds received from the sale of meat, meat food products,

or livestock products, to insure that payment is made to cash sellers of livestock
