State lab to charge for services

HARRISBURG — State Agriculture Secretary Kent D. Shelhamer has announced that on July 1, the State Veterinary Diagnostic Laboratory at Summerdale will institute a fee schedule for diagnostic services performed on food animals such as cattle, sheep and swine.

Shelhamer said that the laboratory will not charge for diagnostic services for the many diseases of livestock and poultry which may affect public health, listing tuberculosis, brucellosis and rabies as examples. He also said diseases that are potentially devastating to the Pennsylvania livestock industry will be evaluated at no charge to the farmer. These diseases include hog

cholera, pseudorabies, anthrax and exotic foreign diseases which "pose a constant threat to Pennsylvania livestock and poultry."

The Agriculture Secretary noted that a fee schedule had been in effect for two years to cover diagnostic work on non-foot animals. Because of its very complete diagnostic services, veterinarians refer much of their diagnostic work to the Bureau of Animal Industry's Summerdale lab.

He said that the new fee

schedule would cover routine diagnostic services, noting that all fees are established at a minimal cost, and will be used to offset the expenses of maintaining the top quality laboratory with diagnostic services for livestock,

poultry and pet animals, including birds.

Shelhamer reiterated that diseases found to be a threat to public health or in regulatory disease programs will continue to be provided at no cost to the Pennsylvania farmer.

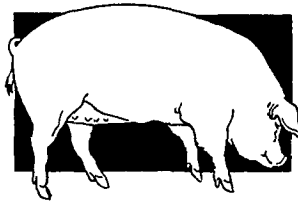
