ANNAPOLIS, MD - Some farmers on Maryland's Lower Eastern Shore are beginning to operate in the red...and they love it!
Fields and patches of Maryland strawberries are starting to turn crimson, and the growers anticipate one of the better years for their tasty crop.
That means its nearing strawberry auction time at Princess Anne according to the Maryland Department of Agriculture, which supplies the graders for the auction. Grading is done on the basis of size, color, condition and cleanliness and is one of the respected features of the strawberry auction. Buyers know what they are getting. Strawberry auction block manager, Russ Borman, has prepared fact sheets for buyers telling them what the
grading designations mean and what the buyer should look for when bidding. Borman also says he expects some fine offerings of Earliglow, Guardian and Darro varieties for the opening of the auction in mid May.
Growers say conditions this Spring have been ex ceptionally fine; and if avorable weather con tinues, Maryland strawberries this yea. hould be firmer, sweeter and tastier than ever.
