## Hubert Miller award presented

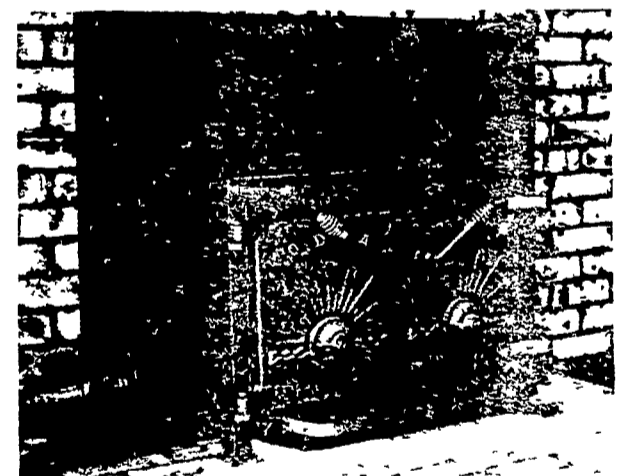

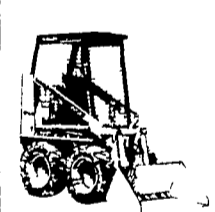
