Swift meat company fined \$2500 by USDA

CHICAGO, Il. — Swift and Co., a nationwide meat packing firm headquartered in Chicago, has been fined \$2500 by the U.S. Department of Agriculture and ordered to stop violating deceptive practice provisions of the Packers and Stockyards Act, USDA announced.

The firm consented to the order, waived oral hearing and neither admitted nor denied the charges in an administrative complaint filed by the USDA.

USDA charged the firm under the P&S Act with selling meat to the Harris County Texas jail and rehabilitation center at false weights by changing the weight marked on the containers of meat and then preparing false invoices and collecting payment on the basis of the false weights.

USDA ordered Swift to stop selling meat at falsely increased weights; labeling containers or altering weight labels on containers to reflect falsely increased weights, and issuing sales invoices showing falsely increased weights.


