guilty at the formal hearing, the Co-op faces two potential consequences: it could have its Pennsylvania license completely revoked, or it could have the license suspended for a given number of days.

In similar cases in the past, suspension has been the typical verdict.

The state's Milk Marketing Law allows any dealer to buy back its suspension at the rate of \$50 a day. The funds from the fine go to the Milk Marketing Board fund.

If the Co-op should be found guilty and should elect to buy back its suspension, the action should not have any effect on Dairylea members other than the revenue loss. Dairylea would not be forced to give up its contract with A&P.

In a separate case evolving from the Dairylea-A&P Scranton deal, arguments were heard Monday in Commonwealth Court on charges leveled against Dairylea by Lehigh Valley Farms February 13, 1980 that Dairylea was involved in illegal tolling.

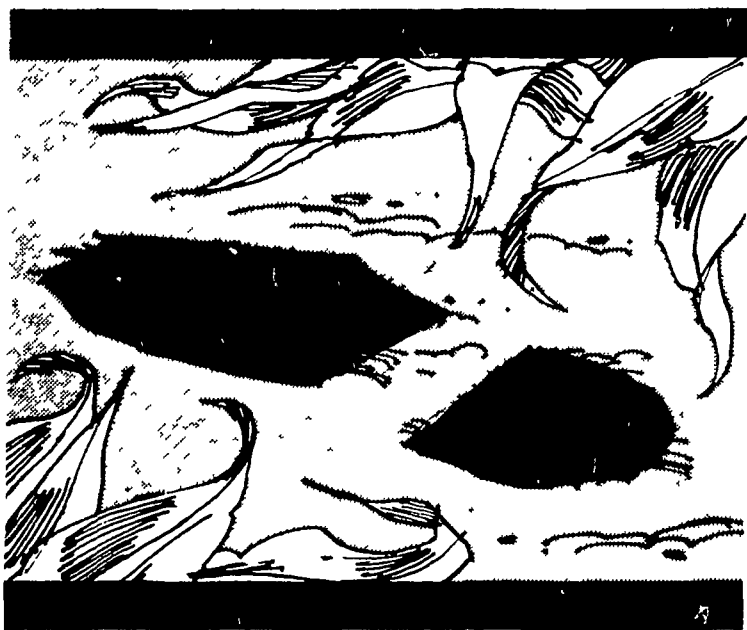

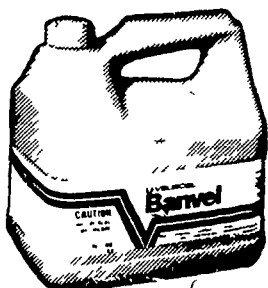
