

Milk starts to flow from Agri-Mark Co-op

BOSTON, Mass — The new Agri-Mark Dairy Cooperative became operational Wednesday following the signing of a consent order with the US. Department of Justice.

The consent order was signed by officials of Agri-Mark, H.P Hood Dairy, and Agway Inc.

The three are parties to the formation of a giant New England dairy cooperative. The Justice Department had stalled the proposal while it investigated any possible improprieties in the new deal.

Under Wednesday's consent order Agway, Agri-Mark, and H.P. Hood agreed to have no common directors, officers, or management.

The full-supply provision proposal, whereby Agri-Mark agreed to supply all milk for H.P. Hood, was cut from a 10 year duration to a one year contract The contract will be renewable annually.

Of course, Agri-Mark will be producing far more milk than H.P. Hood alone can handle.

A further provision of Wednesday's consent order with Justice is that Agri-Mark will supply other handlers and that all buyers of Agri-Mark milk will be treated equally. Hood can receive no special treatment

with Agri-Mark and Agway For five years from the date of the decree, Agri-Mark and H.P Hood are enjoined from buying any dairy or manufacturing plant without the consent of the Justice Department. This is standard procedure

When the parties involved agreed to all of the above operational modifications and several other provisions, the Agri-Mark Co-op became operational. The full text of the

agreement will be published in the Federal Register. Following publication, there will be a 60-day period for comment

Following the comment period, the judge will make a final decision on the continued operations of the coops and firms involved.

Barring any major objections from outside, the partnership should be completed and free to run at that time. The New England super-

Hood has agreed to purchase all of its milk from Agri-Mark for one year with options to renew the contract annually.

Hood will continue to sell dairy products under its own name

Agway's main stake in the deal is owning controlling interest in Hood. Agway is a farmer cooperative This is said to give farmers control of Agri-Mark both through the Agri-Mark Co-op itself and through Agway's board voting the Hood stock.

Agri-Mark was to have an annual production of three billion pounds milk for the deal to be completed. That condition was, for all practical purposes, met at the end of June, according to those involved in the deal — CH

Berks farmers can sign up for disaster benefits


LEESPORT — Feed grain and wheat farmers are eligible for possible farm program benefits, according to Mark Balthaser, chairman of the Berks County ASC Committee. He announced grain growers are eligible for price support loans, low yield disaster benefits and low price insurance.

"Farmers in several Pennsylvania counties have received yield loss on wheat and barley due to hail," he said. "This may happen to corn and other crops before harvest".

Farmers who experience a 40 percent yield loss due to natural disasters are eligible for low yield payments. Wheat growers are eligible for price support loans at \$2.46/bushel for the crop if stored on the farm or in a USDA approved warehouse.

Program eligibility requires that farmers report their crop acreage to ASCS by August 1, 1980. The program provides free insurance against crop failure and commodity prices.

For farmers in western Berks County, the ASCS office will be taking crop reports at the WAY-HAR Farms Store on Route 183 between Bernville and Strausstown on Tuesday, July 22, from 10 a.m to 3 p.m In southeastern Berks, they will be at Sharesville Or chards fruit stand on Route 73 between Oley and Boyertown on Thursday July 24, from 10 a.m. to 5 p.m.
