### Hearing on changes to New England milk order

NEW YORK, N.Y. - A public hearing will be held September 9 on proposed amendments to the New England federal milk marketing order, it was announced today by an official of the U.S. Department of Agriculture.

Herbert L. Forest, dairy official with the Agricultural Marketing Service, said the hearing will convene at 9:30 a.m. at the Holiday Inn, 30 Worcester Road, Framingham, Mass. Dairy farmers, dairy cooperatives, milk handlers, consumer organizations and private

citizens may testify at the hearing and may crossexamine witnesses.

Principal cities in the New England milk order area include Boston, Mass., Hartford, Conn., and Providence, R.I., Forest said. Milk marketing orders set minimum prices that handlers pay dairy farmers for their milk. They do not set the price consumers pay for mulk at retail outlets.

Forest said the key proposals to be heard would revise the pricing structure under the order by reflecting increased hauling costs in

the location adjustments for England Milk Dealers, determination of zone prices at milk plants. Other issues to be herd are proposals concerning pool supply qualification, diversion limits, and the classification of butterfat shrinkage and overage.

The proposals were made by the Association of New




