Stockyard sales quota

appeal upheld

petition to strike down a U.S. Department of Agriculture order permitting Sioux City Stock Yards, Sloux City, Iowa, to establish minimum volumes sales requirements for all market agencies doing business at its facility has been dismissed in a split decision by the U.S. Court of Appeals for the Eight Cirсшt

"This was the first real test we have had on the Packers and Stockyards Act," USDA official James L. Smith said Smith is a deputy administrator of USDA's Agricultural Marketing Service.

"The P&S Act," Smith said, "charges us to promote and maintain fair and open competition in the marketing of livestock, meat and poultry. The rule review by the courts is based on an amendment which insures that owners and operators can run their stockyards smoothly and efficiently, providing a healthy, competitive public market."

Led by Western Iowa Farms Co., 16 of the 23 market agencies handling

SIOUX CITY, Iowa - A livestock at Sioux City Stock Yards filed a petition to review USDA's order on the grounds that the stockyard company's rule was "unreasonable and disciminatory." The order permits the Sioux City division of Union Stockyards Corp. to require market agencies to pay an annual minimum fee equal to yardage fees calculated on the handling of 25,000 cattle and 55,000 hogs.

The rule was initially put into force by Sioux City in September, 1977. At a formal hearing held for petitioners ın Aprıl, 1978, a USDA administrative law judge ordered Sloux City Stock Yards not to enforce the rule. In September, 1979, the secretary of agriculture, through the USDA judicial officer, reversed this position and dimissed the petitioners' complaints. Smith said. The recent ruling by the appeals court upholds this reversal.


