Stewart sentenced to 5 year prison term

WASHINGTON, D.C. — receiving payment for the Former University of Maryland Professor Wolcott E. Stewart, president and sole stockholder of Exchange Market Traders, a commodity broker from Laurel, Maryland was sentenced on Tuesday for 5 years imprisonment for each of three counts of mail fraud. Stewart was charged ten months ago and indicted by Federal Grand Jury in Baltimore, Maryland on 14 counts of Mail Fraud.

The indictment charged that during a three-month period from March, 1978 to June, 1978, Stewart contracted with farmers in Maryland and Pennsylvania to provide their grain to graineries in Baltimore and Salisbury, Maryland and in McGeheysville and Harrisonburg, Virginia. Stewart then instructed the graineries to make payment directly to him for the delivered grain. Upon

receiving payment for the grain, Stewart deposited the money into his own personal account and used the money for his personal gain.

Stewart was arrested by Postal Inspectors on January 17, 1980.

Stewart was convicted on July 11, 1980 of swindling 40 farmers out of \$200,000 worth of grain. He was convicted on three counts of Mail Fraud; the jury was unable to reach a decision on the eleven other counts.

Stewart is appealing the case.






