Pa. produce dealer ineligible to operate

WASHINGTON, DC. — Charles A. Cesnales, Jr., doing business as City Market in Butler, has become ineligible to operate in the produce industry after failing to pay a reparation award of \$10,220 for produce purchased between February and May of 1980.

USDA's Agricultural Marketing Service, which licenses produce firms under the Perishable Agricultural Commodities Act, had charged the firm with failing to pay the agreed price to a Pennsylvania wholesaler.

Charles Brader, marketing

official with AMS, said the firm had been given an opportunity to answer the charges but had failed to do so. Therefore USDA ordered payment of the amount claimed.

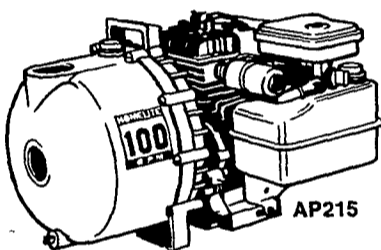
Cesnales is ineligible to conduct business subject to the act until the award is paid and may not be employed by or affiliated with any PACA licensee without USDA approval.

Under PACA, all interstate traders in fresh and frozen fruits and vegetables must be licensed by USDA. USDA is authorized to suspend or revoke a trader's license for violating the act.

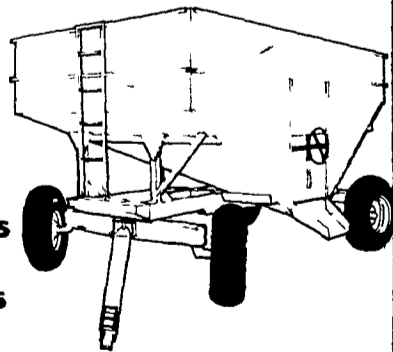

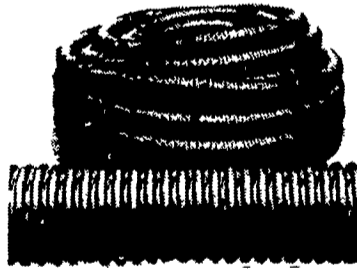

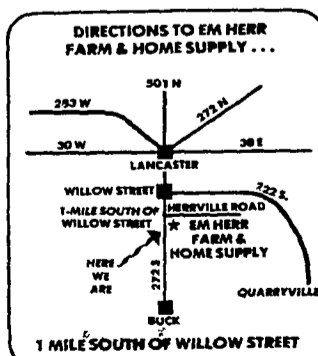
