Thornburgh, Hallowell visit rural bridge project

"This new bridge is a symbol of this administration's commitment to providing rural Pennsylvanians with the best possible transportation system," Thornburgh said. "Nothing is more detrimental to our state's economy than any bridge, regardless of size, which is closed or weight-limited. This bridge will provide agricultural businesses in particular with a link for the movement of their goods and services."

The \$169,279 project began July 27 and will be completed by the end of September under a contract to Thomas A. Mekis and Sons, Inc., of Fenelton, Butler County.

Last June, the General Assembly expressed its confidence in our Transportation Department's ability to carry out vital restoration projects with efficiency and integrity. It did so by approving the kind of predictable and stable funding base I have fought for since taking office," the governor said.

He said that the new oil franchise levy is expected to provide \$192 million in additional funds for Pennsylvania transportation during its first year of enactment.

Since Thornburgh took office, the Department of Transportation has awarded more than 1,600 road and bridge contracts, totalling \$1.3 billion.
