Wasson moves from Pork to Sheep Council

DENVER, Co. - Rodger L. Wasson of Adel, Iowa, coordinator of operations of the National Pork Producers Council located in Des Moines, has been named to head the American Sheep Producers Council as executive director effective January 14, 1982.

Wasson's appointment was announced by Chris Jouflas of Grand Junction, Colorado, president of the Council and a sheepman. Wasson succeeds Dick Biglin as executive director following Biglin's retirement after more than 25 years of service.

"We are very fortunate to have someone like Rodger Wasson to head up the Council," Jouflas said. "He has had a strong background in association management and

will help to organize a strong, creative and enthusiastic promotion force based on a team effort," he added. "Rodger has displayed outstanding ability to organize, to work with people and to manage budgets."

Wasson was born May 24, 1949, in West Central Illinois where his father farmed and raised sheep.

Before serving two years with the Pork Council, Wasson was executive vice president of the Indiana Beef Cattle Association from 1973 to 1979. He had previously worked for ASPC in Denver for one year in 1972-73 as director of the Sheep Industry Development Program.

Bachelor of Science in communications. He married his wife Vickie while they were both in college. He worked for a radio station in Bloomington, Illinois, as a radio farm director until his wife received her degree.

As coordinator of operations,

Wasson has been in charge of supervising the operation of the Pork Council, which includes the office management group consisting of product promotion including advertising, merchandising and consumer communications, and producer

relations which encompasses special activities, the Pork Congress, pork publicity and research and education.

He has had experience working with all species of livestock, including sheep, cattle and hogs, at both the state and national level.

USDA corrects poultry scald rule

WASHINGTON, D.C. — The U.S. Department of Agriculture has issued a correction to a list of poultry scald agents contained in its new rule on substances which meat and poultry plants can use in processing.

The correction on a charge in the final rule shows that 16 poultry

scald agents can be used in amounts "sufficient for the purpose", said Donald L. Houston, administrator of USDA's Food Safety and Inspection Service.

Because those words were madvertently omitted in the Oct. 5 rule, it appeared that the substances could only be used in

amounts "not to exceed 0.0175 percent in scald water," he said.

The first poultry scald agent that should be designated as "permitted for use in amounts sufficient for purpose" is potassium hydroxide, and the last of the 16 agents is tetrasodium pyrophosphate, he said.

This correction was published in the Nov. 13 Federal Register.


