One can speed up the rotting process by applying a high nitrogen tertilizer to the stump. Finley says, "Bacteria needs nitrogen to live, so the application of nitrogen could speed up the decay process."

Burning by itself or in combination with chemicals is often dangerous because the stump can smolder for weeks and the chemicals can be carried through the roots to undesirable areas. Many communities have ordinances banning outdoor fires. Check

local authorites before burning.

Chopping and digging are not easy and requires a sharp ax and strong back. This method works it you are rugged and stubborn enough.

Pulling the stump out with a tractor or bulldozer is generally destructive to the rest of the yard and leaves a very large hole.

Stump removal is not an easy job, Finley says that no one method works well in all situations. Think carefully about all aspects of any method before trying it.

Rabies cases on rise

HARRISBURG - The incidence of rabies has been on the increase in neighboring states and a slight increase has shown up in several Pennsylvania Counties, according to State Agriculture Secretary Penrose Hallowell.

"Fourteen cases of

Rabies appears to be moving northward in skunks and raccoons. and the abundance of these animals will increase the spread of the disease," Hallowell said.

Three cases of rabies in skunks were reported this fall in the State College, Centre County area and one case in the Altoona area. These were the first cases of rabid skunks in Pennsylvania in over two years. The first case of rabies in a cow since 1973, was diagnosed this fall in Adams County.

"Rabies is an acute virus disease which can affect warm-blooded animals including man. The incidence of the disease has been low in recent yéars in most cases found in bats," but, Hallowell said, "it is still a serious problem, certainly one which we cannot afford to take lightly."

The majority of positive rabies cases have involved bats, raccoons and skunks. However, dogs and cats have been found with the disease and pet owners should take precautionery measur-

Hallowell said that a rabies vaccination for a pet dog or cat is a simple, safe and effective way to protect your pet. Rabies vaccine comes in two types: an inactivated virus vaccine which is administered annually, and a modified live virus vacine which is administered every three years.

"If bitten by an animal or bat, the person should take several precautions," Hallowell said. "Don't panic, try to identify the animal. Never ignore an animal bite. Wash the wound with soap and a lot of water and call your physician. Bites should be reported to the police.

"Do not try to catch or kill the animal unless absolutely necessary," Hallowell said. "The police or our State Dog Law Officers are trained and better equipped for that job."

Pet owners who suspect their animal has been exposed to a rabid animal should confine the pet and immediately call a veterinarian for professional advice. The incubation period of rabies varies from a few weeks to more than a

Hallowell noted the Department's Summerdale Laboratory provides rabies diagnostic services free of charge. Results of diagnostic testing are reported to the concerned individuals as soon as testing procedures are complete.
