Dr. Meyer directs and coordinates all quality control, technical service functions and lab activities for Cobb on a worldwide basis. Dr. Botero is responsible for poultry health testing procedures at Cobb's Quality Assurance Laboratory, monitors and farm's flock sanitation and vaccination procedures and conducts practical poultry disease-related research.

Lab coordinator Bergeron handles daily lab activities, and performs and analyzes tests designed to maintain the diseasefree status of Cobb's production flocks. Lab research assistant Newsome is responsible for much of the virological testing and works closely with Bergeron.

N.Y. bulls get first "grades"

ITHACA, N.Y. — "Report cards" have been issued for the 80 registered bulls at the conclusion of the first 28-day weigh period of the New York Bull Test. The overall average daily gain for the 80 bulls for the "first marking period" was 3.28 pounds.

The 35 Angus bulls led the test group with an overall average daily gain of 3.55 pounds. Close behind were three Shorthorn bulls with an average daily gain of 3.51 pounds. The eleven Simmental bulls had an average daily gain of 3.10 pounds. The average daily gain for the nine Charolais bulls and the eighteen Polled Hereford bulls was 3.07 pounds. The average daily gain for the three Red Angus bulls was 2.97 pounds and for the one Salers bull, 1.96 pounds. A Simmental bull enrolled by Linden Farms of LaGrangeville leads the bulls on test with an average daily gain of 5.19 pounds for the first 28day period.

The 1982-83 Bull Test program is jointly sponsored by the New York Beef Cattlemen's Association, Cooperative Extension, the State Department of Agriculture and Markets and the animal science department at Cornell University. The 140-day performance testing program is conducted under uniform, unbiased conditions at Cornell's Livestock Teaching and Research Center at Harford.

The performance testing program is designed to measure the genetic merit of potential herd sires and identifies those bulls that are genetically superior in the efficient production of red meat. Those bulls who meet certification standards at the conclusion of the test will be offered at the Bull Test Sale May 6 at Ithaca.
