The contest is sponsored by the Pennsylvania Apple Marketing Board in cooperation with the State Horticultural Association of Pennsylvania.

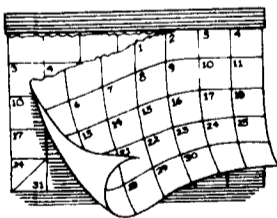
A Pennsylvania processed apple product must be an ingredient in the recipe. Appearance, taste, economy, appeal and ease of preparation round out the judging criteria.

The contest is open to all Pennsylvania residents. You may enter by sending your name, address,

phone number, recipe name and recipe to: Apple Recipe Contest, Pa. Apple Marketing Board, 2301 North Cameron Street, Harrisburg, PA 17110.

All entries submitted must be scratch recipes and should list the name, all ingredients and their quantities, and step-by-step mixing and cooking instructions. Only one entry per contestant is allowed. Entries must be post-marked no later than Dec. 31. Ten finalists selected from submitted entries must appear at the Hershey Convention Center with completed, prepared recipes to be eligible for final judging. Judging will take place in conjunction with the annual meeting of the State Horticultural Association in January. Finalists are reimbursed for round-trip mileage and treated to a complimentary luncheon.

All recipes become the property of the Pennsylvania Apple Marketing Board of publicity and other purposes. Winning entries will be published in an apple recipe booklet.

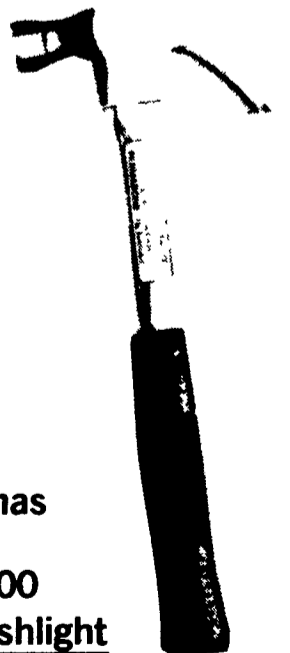
