USDA accepting applications

from noncertified egg producer groups

WASHINGTON, D.C. — Egg producer groups that want to nominate members and alternates to the American Egg Board must apply to the U.S. Department of Agriculture for certification by June 15.

H. Cohnor Kennett, an official with USDA's Agricultural Marketing Service, said only egg producer groups certified by the secretary of agriculture will be allowed to submit nominees. After the organizations are certified, USDA will aks for nominations to fill the two-year terms of nine members and their alternates whose terms expire at the end of 1984. Half of the membership of the board is replaced each year. Kennett said organizations already certified need not reapply. During the summer, certified organizations will be mailed information on how to nominate people.

The 18-member board administers the producer-sponsored national research and promotion program designed to strengthen the egg industry's position in the marketplace. Activities are carried out under the research and promotion program authorized by the Egg Research and Consumer Information Act.


