Ag law sessions scheduled

LANCASTER - The Pennsylvania Bar Institute, in cooperation with the Agricultural Law Committee of the Pennsylvania Bar Association, will sponsor its annual Agricultural Law Conference in Lancaster on Thursday and Friday. The theme of the one-and-one-half day program will be "The Business of Agriculture.'

The program will begin with presentations by Penn State University extension specialists on

production and livestock agriculture. Lester A. Burdette, Animal Science Extension, will discuss the changing nature of agriculture; Virgil E. Crowley, farm Management Extension, will speak on the role of government; Emeritus Frederick A. Hughes, Farm Management Extension, will explain the capital needs of dairy, grain and livestock farand H. Louis Moore, mers; Agriculture Economics Extension, will analyse the marketing of farm

goods and related problems.

Thursday evening's dinner program will feature guest speakers Robert Bor, Esq., Chief Counsel, U.S. House of Representatives Agriculture Committée, and Robert J. Gray, Director of Policy Development, American Farmland Trust, who will examine the future of agriculture.

On Friday, the conference will focus on selected issues in agricultural law. Professor Keith Meyer, University of Kansas School of Law and President-Elect, American Agricultural Law Association, will discuss UCC Articles II and IX as they relate to

agricultural transactions; Jonathan Landers, Morrison & Foerster, San Francisco, will speak on Chapter 11 reorganizations and the effects of the new bankruptcy laws; and farm labor issues will be covered by Robert Bor and Keith Eckel, President, Pennsylvania Farmers Association.

Guest speaker for Friday's luncheon will be Garth Youngberg, Director of the Institute for Alternative Agriculture, who will address the character and future prospects of alternative agriculture.

The program will conclude with a review of significant develop-

ments in agricultural law, featuring D. Timothy Tammany, Tax Counsel for Cigna Corporation, Philadelphia, on taxation and estate planning; Professor Gerald Torres, University of Minnesota School of Law, on land use planning and environmental law; Edward Thompson Jr., Esq., American Farmland Trust, on agricultural zoning; William Hoffmeyer, Esq., Hoffmeyer & Semmelman, York, on real estate; John C. Becker, Esq., Agricultural Law Specialist, Penn State University, on the regulation of agriculture; and Lawrence B. Kurland, Esq., Lawrence B. Kurland Associates, West Chester.


Lush award presented

DE FOREST, Wisc. - A.E. Freeman of Iowa State University. Ames, Iowa, was named recipient of the J.L. Lush Award at the recent American Dairy Science Association's (ADSA) annual meeting in College Station, Texas.

The award, in the form of a plaque and \$1,500.00 is sponsored by ABS and was presented by Dr Walton. It is awarded annually in recognition of the exceptional contributions made by Dr. Lush to the Science of Animal Breeding

Freeman, the third person to receive this award, received Bachelor of Science and Master of Science degrees from West Virginia University. He received his Ph.D. in Animal Breeding from Cornell and began his professional career when he joined the staff at Iowa State University working with Dr. Lush. He later succeeded Dr. Lush as leader of the animal breeding group at the institution. He has been regularly involved in both undergraduate and graduate teaching.

Much of Dr. Freeman's research has dealt with the genetic improvement of dairy cattle including the inheritance of milk constituents, type characteristics, dystocia, the relationship of production and reproduction, inbreeding effects and numerous other nonproduction traits. He has worked cooperatively with several A.I. organizations.
