Farm Bill ideas cited

HARRISBURG — The nation's general farm organizations will have a stronger role in the development of the 1985 Farm Bill than they did in 1981, according to James Miller, assistant legislative director for the National Grange. Miller spoke before the legislative, agriculture and dairy committees of the Pennsylvania State Grange at a pre-session policy meeting in Carlisle.

Miller pointed to the fact that the 1985 Farm Bill is not going to be written on a commodity by commodity basis, and therefore a more general approach to farm policy will be taken. "This farm bill is going to be different," he said. "There will be more actors involved in its development than ever before."

The new farm legislation will cover everything from price supports to food stamps, Miller said. "As a result, some very innovative things are likely to come out of it," he predicted. He said ideas being touted in Washington circles range from requiring more cross compliance on conservation

programs, to eliminating research designed to increase farm productivity, to developing a direct farm subsidy program based on a farmer's means.

The dairy price support program is also certain to be a subject for debate, according to Miller. "The result is going to be a free for all or

Right to Know

Noah Wenger, farmer-senator from Lancaster County, was the center of attention on Right to Know legislation as chairman of the Labor and Industry Committee. Wenger was leading the effort to amend legislation passed in the House which carried stringent regulations concerning chemicals that would affect farming operations. Some of these major amendments were concerned with labeling equipment such as drills and sprayers, posting of a central location for employes instead of every field receiving chemical applications, definition of a manufacturer that would not include a farmer just because he mixed chemicals and limiting information to be supplied emergency crews to major hazardous substances.

Ag Products Commission

There's a Senate bill to create an Ag Products Development Commission to oversee the promotion of Pennsylvania agricultural products in a manner similar to that of other states. Since it entails a \$100,000 appropriation, it requires Appropriations Committee action.

Property Tax Exemptions

There is pending legialtion to exclude grains bins and corn crips from property taxes in order to standardize regulations throughout the state. In some counties, they are taxed and in some they are not.

Poultry Payments

There's a House bill requiring that poultry contracts contain provisions for prompt payment to farmers – 14 days or a time period of mutual agreement between the buyer and seller.

other and would serve separate parts of the state.

Concerning the A and B plant effort, a session was held on Monday among hog producers in Adams County. The proposed coop's steering committee was also scheduled to meet this week to select an attorney for the drafting of agreements and other paperwork.

In the A and B co-op, hog producers are being asked to put up \$1,000 to provide seed money for the application for state-backed funds for the proposed plant purchase.

It is expected that a session will be called in the near future among enrolled hog producers to proceed with the co-op formation.

This week's session of debtors with claims in the Chapter 11 bankruptcy of A and B before a federal judge in Reading included a 37 percent payment to hog producers who are still owed money for livestock.

It was at this session that it was announced the co-op group has appeared as the most likely purchaser of the plant.
