Market Comment: Prices unchanged. Demand for graded product was fairly good for the most part, but end of the week orders were tending to reflect lesser needs at the retail level in some quarters. Retail featuring was light but was adding to movement in some instances. Floor stocks remained in irregular balance but were generally adequate or available on all the jumbos. Ungraded offerings remained light and were often noted as confidently held, particularly on class grade-outs of large and heavier weight size.

Report supplied by USDA Market Comment: Prices generally unchanged. Seller offerings only spotty at best and adequate to short of full plant requirements. Plant schedules light and further reduced on a holiday period. Some inquiries from midwestern concerns adding stability to the undertone. Finished product sales also light with buyer offering resistance to seller asking prices.

Market Comment: Movement of ready to cook whole birds and parts was improved. Whole bird clearances were generally wellmaintained. Discounting on dark part items was little if any factor in movement in most plants today. Live supplies were adequate to barely adequate. Weights were mixed but mostly desirable to heavier than desired. Slaughter schedules were moderate. The undertone was steady to fully steady.


